RE: Enhanced High-pH Therapy for Cancer now available through Dr. Sartori in Thailand

Dear _____:

Thank you for contacting me to enquire about Cesium chloride (CsCl) and the Enhanced High -pH Therapy for Cancer that had been originated by A. Keith Brewer, Ph.D., and since 1980 enhanced and perfected by myself. Though the results were published in a major peer-reviewed medical journal, *Pharmacology, Biochemistry, and Behavior* in the December 1984 Supplement I, there was, except for the late Dr. Hans Nieper, a minimum of response from both the orthodox and alternative medical community. Therefore, unfortunately, I am the only physician left who uses this **by far most consistently effective therapy for fast-growing cancers no matter what stage or type or extent.**

In the last 25 years, over 700 cancer patients have been treated with this therapy. In all cases, **fast-growing tumors were promptly reduced in size with minimum discomfort to the patient** (which is common and typical for chemotherapy and after radiation). With the intravenous (I.V.) application of this therapy, we consistently achieved tumor reductions of 1.0 to 2.0 cm (2/5 to 2/5 of an inch) per day, i.e., disappearance of 5.0 cm (2.0") tumors in about four days, and of 10.0 cm (4.0") tumors in about eight days. Besides the higher and more consistent effectiveness, I.V. application of CsCl and other minerals, vitamins, mandelonitriles (e.g., Laetrile®) avoids all side effects from oral therapy such as nausea, vomiting, diarrhea, abdominal discomfort, etc. Furthermore, I.V. application guarantees that all ingredients are taken up by the body whereas absorption may be compromised, particularly in patients with any type of malabsorption from gastrointestinal problems or in many advanced cancers. The only "side effects" seen with this enhanced therapy is the sometimes considerable, but brief, discomfort from the I.V. application of Ozone that is, in fact a most beneficial homeopathic -type "healing crisis".

The Enhanced High-pH Therapy for cancer is now available in Thailand at a fraction of the financial costs of any conventional therapy that, besides very poor results in most cancers, causes severe suffering and in many cases permanent damages, and is the main cause for premature deaths in cancer patients. In 35 years of "War on Cancer", the yearly death rate in the U.S.A. went up from 135,000 to over 800,000 and the average cost per patient is around US\$ 200,000.00 (\$ 100,000 to over \$ 1,000,000.00) with an average out of pocket expenses for insured patients of about \$ 40,000.00 (\$ 20k to 200k). Compared with this, the total all-inclusive investment for two weeks of the Enhanced High-pH Therapy for cancer in Thailand (with room & board for a companion) is US\$ 16,000 (€ 14,000/AUS\$ 24,000/¥ 1,800,000/CAN\$ 20,000) of which \$/€5,000 (AUS\$ 7,500.00/¥ 500,000/ CAN\$ 6000) is to be paid on in advance to insure payment for the needed supplies. The remaining \$ 11,000 (€9000/AUS\$ 16,500 /¥ 1,300,000/CAN\$ 14,000) is due upon arrival at Dr. Wong's Hospital. In the rare cases of tumors over 10 kg (22 lbs), we highly recommend to extend the treatment course at least one day per kg (2.2 lbs) for \$ 800 (€700/AUS\$ 1200/¥ 90,000/CAN\$ 1000) per day. If you are one of those patients that seek us out first when their primary tumor is less than 5.0 cm (2.0") in diameter (and which have not yet undergone any conventional treatment), the treatment course is eight days at a total investment of \$ 11,000 (€9000/ \$AUS 17,500 /¥ 1,250,000/CAN\$ 14,000). In all cases, the fee includes follow-up consultations for a period of six months after completion of the treatment. The fee for Telephone Consultations with Dr. Sartori is US\$ 300 (€250 /\$AUS 400/¥ 35,000/CAN\$ 350) per hour of which up to \$ 3,000 (€2,500/\$AUS 4,000/¥ 350,000/CAN\$ 3500) will be deducted from your investment into the Enhanced High pH Therapy if you should decide to take the treatment at Dr Wong's Hospital. AGREEMENT *RE* TREATMENT OF PATIENTS WITH ALTERNATIVE MEDICINES AT DR. WONG'S HOSPITAL

1. This agreement is made to assure the highest level of medical care with alternative medicines available anywhere and is made between Dr. Wongsawang Kanchanakanom, later herein "Dr. Wong", the owner and Medical Director of Dr. Wong's Hospital, and Dr. Abdul-Haqq H.E. Sartori, later herein "Dr. Sartori", who will bring patients to Dr. Wong's Hospital and will act as consultant to Dr. Wong regarding his alternative medical protocols.
2. **Dr. Wong's Hospital** under its distinguished Director Dr. Wong is **the leading hospital for alternative medicines in Northern Thailand** and thus uniquely qualified to provide the highest level of alternative medical care available anywhere, for patients from Thailand and foreign countries. Dr. Sartori has devised **empirically proven highly effective treatment protocols for the treatment of cancer and other degenerative diseases** with parenteral oxidative and substrate therapies. He will act as consultant to Dr. Wong and also provide all devices and materials needed for these therapies.
3. All of Dr. Sartori's treatments will be performed under the overall supervision of Dr. Wong by a staff specifically trained by Dr. Sartori.
4. The fee paid by Dr. Sartori to Dr. Wong includes:
 - (a) One Deluxe Room for the patient and his/her companion/spouse.
 - (b) Blood-type specific diet for the patient (and companion, if any).
 - (c) Central venous access for the patient, including all ancillary services therefor.
 - (d) A regular single room for a specially trained English-speaking nurse, if the latter is available, for the time of the treatment; or, alternatively, a student speaking the language of a foreign patient.
